Brief Biography:

I completed my Bachelor of Business Administration (BBA) from the University of Chittagong (CU) in 2004 major in Accounting, had my Masters of Business Administration (MBA) in 2005 and a Masters of Philosophy (MPhil) in 2014 from the same University with my major in Accounting and Information Systems. I had my Cost and Management Accountancy (CMA) Degree from the Institute of Cost and Management Accountants of Bangladesh (ICMAB) in 2016. Then, I had my PhD Degree titled "Value Added Tax in Bangladesh: Legal Framework, Contribution to National Exchequer and Its Compliance in Corporate Sector" in 2017 from the University of Chittagong.
